Priority #1: Health and Safety of Children, Staff, and Families

- Base all reopening plans on safe operations of school.
- Invest in resources to minimize risk (HVAC, monitoring, and cleaning).
- Routinize and sustain training, protocols, and daily screenings.
- Adhere to social distancing guidelines and wear masks at all times.
- Coordinate with health agencies and medical personnel.
- Communicate effectively between school and home.

Educational Priorities

- Nurture children's social and emotional well-being.
- Maximize small-group, supportive, synchronous interactions.
- Foster sense of community and belonging.
- Use child-centered diagnostic assessments.
- Focus on curriculum standards.
- Build digital fluency and citizenship skills.
- Bring students back to school as much as possible.

- Social distancing and safety guidelines
- High student enrollment
- Building capacity (square footage)
- State Education Department restrictions for facilities use
- Contract provisions
- Budget

School Operations



Child Nutrition

- Food will be distributed to students daily.
- Students in morning sessions will receive lunch for that day and breakfast for the next when they leave.
- Students in afternoon sessions will receive breakfast and lunch for the following day when they leave.
- Students with allergies will receive appropriate meals.
- The district will continue to use a grab-and-go system.
- Students will not eat on school grounds.

Transportation

- The number of students on each bus will likely be reduced as we expect most nonpublic schools to reduce attendance by 50% each day.
- Buses will be cleaned and disinfected between the morning and afternoon runs.
- When temperatures are above 45 degrees Fahrenheit, school buses will transport passengers with roof hatches or windows slightly opened to provide air flow.
- Bus drivers and attendants will wear masks and gloves.
- Bus drivers will be instructed to wash their hands with soap and water before and after all runs.
- Students will maintain appropriate distance when embarking and disembarking the bus.
- Buses will be loaded back to front and unloaded front to back.
- Bus routing will be done based on school schedules.
- Families accessing public transit will be reminded to wear masks and practice social distancing.



Student Support Services: Special Education and Mental Health



Special Education

- Provision of IEP services to the greatest extent possible.
- Flexibility of IEP service delivery must exist until return to normal operating conditions.
- Contact from service providers to detail how/when services are delivered.
- Accommodations and modifications which ensure access to the general education curriculum will be maintained.



Special Education

- In-person services will be a priority for our most significantly disabled students.
- Progress on IEP goals will be monitored and communicated.
- Reevaluations and initial evaluations will be completed in person or through validated forms of tele-assessment.
- Committee on Special Education meetings will continue to be held virtually until further notice.




Mental Health

- DW Crisis Team will meet weekly with community agencies to share information, develop programs, and make referrals.
- Identification of vulnerable students/families and provision of multi-level tiers of support.
- Hotline monitored daily by district social workers.
- Development of building level structures which serve to assess, monitor, and support social-emotional learning and a sense of connection and community.



Elementary Schools: Students attend school for a half day every day.





Guiding Factors for Elementary Schools:

- To provide in-person teaching and learning for every student, every day, utilizing a 50% capacity AM/PM model.
- To maximize in-person teaching and learning while maintaining the highest level of health and safety.
- Prioritize assessment of students, literacy and math upon re-entry of students in September and then transition to a full standards-based curriculum.
- To establish learning communities between teachers and students with a focus on social and emotional learning and connections.

- Asynchronous learning plan assignments
- Synchronous special (if not received in the PM).

11:30 - 12:30: Lunch

12:30 - 2:00: Mix of Synchronous and Asynchronous instruction, made up of:

- Synchronous small group lessons with classroom teacher
- Asynchronous learning plan assignments
- Synchronous special (if not received in the AM)

2:00 - 2:30: Synchronous Wrap Up with Classroom Teacher and Whole Class

2:30 - 3:00: Completion of Asynchronous Work

3:00 - 3:30: Classroom Teacher Office Hours -Tuesdays & Thursday (Specialists - Mondays, Tuesdays & Thursdays)

- Students on Teams Divided into Five Sections for Core Classes
- Flexibility of Model for Both Hybrid and Remote
- Targeted Support for Academics and SEL

High School: Students attend school for a portion of the day three or four times per week.

Guiding Factors at High School:

- To maximize daily in-person attendance while maintaining the highest level of health and safety.
- To maintain students' schedules and "normalcy" which includes choices of classes and electives.
- Foster connectedness through advisory program.
- To reduce movement throughout the building.
